

Expect the Unexpected this Flu Season



Introduction

As the nation continues the journey back to a new form of normalcy with COVID-19 vaccination adoption across a growing number of demographics, many experts are still cautious about the implications of the 2021/2022 flu season. While cases and deaths have seen new peaks and valleys in pockets of the country during the summer months, the infection rate will rise again in the fall and could be significantly higher by winter. Without herd immunity—which experts say needs to be around 70% (now upgraded to 80% with new COVID-19 variants emerging)—uncertainty rules the day. To prevent this revival, experts believe we need a vaccination rate of 80%-85% by the end of the year.¹

When adding in the wide gap in the percentage of people who have been vaccinated by state (as of September 2021, a low of 38.45% in Mississippi and a high of 68% in Vermont²) and the implications of the normal seasonal flu, there are varying opinions about how healthcare facilities should approach the upcoming season. In addition, changes in policy toward school reopenings, and the rapidly evolving recommended vaccination age range for children under 18, are leaving many with more questions than answers. The fact that people were social distancing and wearing masks during the normal 2020/2021 flu season may also be a factor as infection rates were very low last year, hence people may choose to forego the recommended annual flu vaccination.

To help policymakers make appropriate decisions for the remainder of 2021 and into 2022, The Centers for Disease Control (CDC) has compiled guidance that should be considered as part of a strategy for how we handle upcoming fluctuations in COVID-19 infection rates, the seasonal flu strains that will emerge later in the year, and the necessity for booster COVID-19 vaccinations.

The Precarious Supply Chain: What You Should Know


The CDC's guidance for vaccination and flu strategies covers a wide range of outcomes³. In some places, the robust demand for flu vaccines and the supplies required to support flu vaccination efforts—like needles or syringes—could cause some providers to run out of vaccine supplies before their next shipment has arrived. To combat this, the CDC is recommending that vaccine providers stay updated on supply chain issues and any other guidance that may emerge during the coming months.

Vaccine manufacturers have said that they will produce between 194 and 198 million doses of seasonal flu vaccine this year. While this isn't enough for every person in the U.S. to receive a flu vaccine, past adoption supports that not everyone chooses to get vaccinated. For example, last season, only about half of Americans chose to get a flu vaccine and, in general, there are many doses of flu vaccine that go unused every season.

That said, demand for the flu vaccine may be greater this season because of the COVID-19 pandemic. And while it would be unusual, it is possible that all flu vaccines will be used this season. The CDC has set a goal for every available dose of flu vaccine to be used in the coming season. In addition, even though it is impossible to predict with certainty what will happen in the fall and winter months, the CDC believes it's likely that flu viruses and the virus that causes COVID-19 will both be spreading, hence the necessity for the seasonal vaccine is heightened.

Finally, the issue of COVID-19 booster shots is also top of mind for policymakers and consumers alike. Per a recent article in The Wall Street Journal⁴, manufacturer studies are currently underway to determine the need for booster shots. The argument towards a COVID-19 booster is further emphasized because of current and unknown variants that are cropping up across the globe. As early as April 2021, Pfizer, for example, noted that their vaccine remained effective for six months following the administration of the second dose.

Return-to-work mandates for onsite employees across many industries	Keeping abreast of return to work mandates that could push available clinicians into private enterprise and impact clinician availability
Scheduled time off (maybe even mandatory breaks) for full-time personnel and a corresponding coverage strategy	Earlier scheduling of staffing needs to combat these shortages
